Stall Reservations and Stabling Information

2014 State 4-H Horse Show

Deadline for stall reservations: **No later than October 10.** Please observe this deadline!
NO refunds will be made for stalls canceled **after October 10.**
NO reservations will be accepted by fax.

Stalls will be available: ***No earlier than 11:00 a.m. Thursday, October 23.***
Must be vacated within two hours of the end of the show or
earlier as announced on Sunday, October 26.

Bedding Policy: The show contract for use of the Farm Show facilities requires payment for the removal of bedding from the complex. The current stall fees include fees for bedding removal. NO foam board, carpet, etc. allowed in stalls. If bedding containing debris such as foam board, carpet, padding, etc. is found in stalls, all exhibitors will lose the option of using shavings in future years. The bedding removal hauler will not accept bedding with debris.

Exhibitors may be disqualified and fined \$100 if found violating this policy.

Stall fees: *Stall fees are per stall for the entire show, from Thursday through Sunday.*
\$75.00 per horse or tack stall

Each county has the option of reserving at least one tack stall. More than one tack stall may be reserved if the following guidelines apply:

1-5 horse stalls	one tack stall	26-30 stalls	six tack stalls
6-10 horse stalls	two tack stalls	31-35 stalls	seven tack stalls
11-15 horse stalls	three tack stalls	36-40 stalls	eight tack stalls
16 -20 horse stalls	four tack stalls	41-45 stalls	nine tack stalls
21 - 25 horse stalls	five tack stalls	46 stalls & over	ten tack stalls

All stalls must be reserved on a county basis. Each county is permitted to reserve a number of stalls equal to the total number of horses entered in the state show from the county. It is not mandatory to have a stall for each horse entered. Each county must coordinate stall requirements.

The state show committee will not assign individual horses to stalls. Each county **MUST** designate an extension educator or leader who is responsible for individual stall assignments within the stabling area assigned to the county. The name of the individual responsible for coordinating stabling requirements for each county **MUST** be designated on the enclosed form.

If there are scratches or additions of entries from your county that result in changes in your county stall reservations, please notify Darla Shick immediately.
